The Project

TRANSDANUBE aims at developing sustainable mobility along the Danube by promoting train, bus, bike and ship transport to disseminate the concept of sustainable tourism in the whole Danube region. Funded by the South East Europe Program, TRANSDANUBE is a transnational project with 14 financing partners from 6 countries and more than 35 associated strategic partners and observers.

TRANSDANUBE contributes to the achievement of the objectives of European policies and strategies, especially the implementation of the European Strategy for the Danube Region.

Background

The Danube is a river of highly transnational character, passing 10 countries on its way from the Black Forest to the Black Sea. It is one of the major transport axes in South East Europe, which is a big opportunity for economic growth. The Danube Region is also an upcoming tourist destination, although it faces some challenges like negative environmental effects and limited accessibility of the regions.

The European Commission, together with the Danube Region countries and the relevant stakeholders, jointly identified a need for cooperation to stimulate the development of the Danube Region. With the endorsement of the European Strategy for the Danube Region in 2011, the member states declared their intention to take common action.

Improvement of sustainable transport along and around the Danube is essential in order to foster sustainable tourism development and to upgrade transport connections for the people living in the Danube regions and surrounding areas.
